CK 105.5's "YUNG GRAVY TICKETS" CONTEST OFFICIAL RULES

Eligibility. CK 105.5 will no longer provide prize substitutions for tickets of shows or tours that are cancelled by the artist, artist management or venue.

Winner Selection. On or about 11:00 am ET on November 14, 2022, Station will select one potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
